Strategic Plan Development

Rosamond Community Services District is currently in the process of developing a strategic plan. This plan will help guide RCSD over the next five years, setting new goals developed by both the community and the RCSD Board and staff.

On August 14th, RCSD held a community only meeting to receive initial input on community priorities and goals. Community members in attendance provided recommendations of what they would like to see implemented by RCSD. With the information from this meeting, as well as input from the RCSD Board, Senior Staff, Line Staff and General Manager, a draft Specific Plan will be produced.

On September 9th, at 2:00 pm, the RCSD Board will hold a workshop to examine and enhance the draft Strategic Plan. At this public meeting, the board will discuss specific items within the plan and provide corrections and additions. We look forward to the meeting yielding comments that will allow for the creation of a final draft of the plan.

The final draft of the Strategic Plan is tentatively scheduled to be presented to the RCSD Board for adoption at the October 22nd regular Board meeting.
