

## **Drought Continues Despite Storms**

The California Drought continues, despite winter storms delivering above-average rain and snowfall in December 2022 and January 2023. The California Department of Water Resources (DWR) reported that the statewide snowpack was 77% above average on January 3rd, 2023. However, DWR cautioned that we saw similar winter storms ease the drought last year before some of the driest weather in state history plunged most of California back into Extreme Drought conditions by May 2022.

The graph above shows drought conditions in Kern County from January 2021 to January 2023. The colors show what percentage of Kern County was in each drought category, from green (No Drought) to black (Exceptional Drought) each month. The red/dark red section between the two black blocks represents the impact of the winter storms we had in December 2021 and January 2022. You can see that the impact of the rain and snowfall from the storms was significant but short-lived.

In December 2022, the State Water Resources Control Board extended the emergency regulation banning wasteful water practices (like watering lawns when it rains) until January 2024. RCSD remains in Stage 2 No Waste Program Guidelines and will bring updates from the state as they become available.

## **Billing Software Conversion Complete**

## **Stage 2 No Waste Program Guidelines**

## Lawn and Landscape Watering

- Watering every other day or less frequently (You pick the days)
- No more than 11 minutes per watering station each morning and/or evening (No limit on drip systems)
- No watering between 7am and 8pm, April through September
- No watering between 10am and 6pm, October through March (You can water anytime during freezing weather)

#### **Other Water Waste Limits**

- · Avoid irrigation runoff, especially anything longer than 5 minutes
- Fix water leaks within 24 hours of discovery
- No spraying down paved areas (sidewalk, driveway, patio, etc.)
- · Only wash cars with a shutoff nozzle on the hose
- Decorative ponds, fountains, pools, and lakes must recirculate water.
- · Water by request at restaurants
